

Audyogik Shikshan Mandal (ASM) and **University of Applied Sciences in Nysa** agree to implement this Memorandum of Understanding signed on 09-01-2016.

This agreement is based on the principle of reciprocity and expresses the interest of both parties in exchanging scholars, students, academic information, and materials in the belief that the research and educational process at both institutions will be enhanced and that mutual understanding between their respective scholars and students will be increased by the establishment of such exchange programs. This agreement must stay with national regulations in India and Poland.

1. The universities/institutions agree to encourage the development of the following programs and activities, based on their respective academic and educational needs:
 - Exchange of faculty
 - Exchange of students(undergraduate and/or graduate)
 - Exchange of academic information and materials
 - Organization of joint research programs and publications
 - Organization of joint conferences
 - Organization of student visits and seminars
 - Organization of other joint academic activities agreeable to both universities

2. The parties recognize that the implementation of any exchange program will depend upon the academic interests and expertise of individual faculty members and upon the availability of financial resources. Accordingly, the implementation of each exchange program based on this agreement shall be discussed and finalized on mutually agreed terms and conditions.
3. The Indo-European Education Foundation (IEEF), Warsaw, Poland, will be party to this collaboration, arrangement and will provide all necessary support.
4. This agreement is not intended to be a legally binding document. It is meant to describe the nature and to suggest the guidelines of the cooperation described above. Nothing therefore shall diminish the full autonomy of either institution, nor will any constraints be imposed by either upon the other in carrying out the agreement.
5. The agreement shall become effective on the day representatives of both institutions affix their signatures and seals, will be in force for a period of 5 years, and is subject to revision or modification by mutual agreement. It is also understood that either institution may terminate the agreement at any time, giving sixty (60) days prior written notice, although it is assumed that such action would only be taken after mutual consultation in order to avoid any possible inconvenience to the other institution.
6. For ASM, Dr. S B Mathur, shall serve as liaison officer and, for the University of Applied Sciences in Nysa, Ms Anna Opalka shall serve as liaison officer, for this agreement.
